It is a 'not for profit' registered Community Benefit Society and is set-up to maintain and/or improve the physical, social and economic infrastructure. They often start, through provision of affordable homes usually in partnership with a Housing Association, which is what Marshwood CLT did at Bramblehay

Our Aim for Marshwood CLT

The aim of the CLT is to provide a vehicle for the local community to own, develop and protect land and property for the community benefit, in perpetuity (lasting forever)

- Provide permanent housing for people with a strong local connection through all their life stages
- Acquire, develop and care for assets that benefit our community

Our Initial Goal

Our initial goal in 2012 was to provide affordable housing on a rental or shared ownership basis for people with a strong local connection in partnership with Dorset Council & Housing Association

- through living or working in the parish & surrounding areas
- or having family living within the community

Bramblehay Success

In 2016, we achieved our initial goal, with the completion of Bramblehay, located within the village of Marshwood. It consists of seven (7) houses complex which will remain affordable in perpetuity (lasting forever)

Other achievements

Financial support provided for community projects such as a Defibrillator, First Aid Training, repairing fingerposts signage, support during COVID, Whitchurch preschool, Baby Changer for Blackdown Village Hall, Hi Vis jackets and books for children of Marshwood school.

Where does the money come from?

The CLT owns the land upon which the affordable homes are built, we receive an income from the ground rent which is sufficient to cover the CLT's running costs and provide a small income for other projects. The CLT, is therefore, financially sustainable. The CLT opens doors to grants from government organisations or funders who support community projects.

Who Manages all this?

The CLT is a registered Community Benefit Society No 31719R. The board of directors are local people who work voluntarily. Any surplus funds are used for community benefit. Our current registered rural housing association is Hastoe, who manages Bramblehay.
